For international flights, check-in deadlines are earlier due to additional security and documentation requirements. Airport check-in usually closes 60 minutes before departure, and checked baggage must also be dropped off by that time or earlier, depending on the airport. Boarding gates for both domestic and international flights typically close about 15 minutes before departure, and passengers must be at the gate before this time.

To avoid any issues, Delta generally recommends arriving at the airport at least two hours before domestic flights and three hours before international flights. These arrival times allow enough margin for check-in, baggage drop, security screening, and reaching the gate without unnecessary stress.

How do I check-in for a flight?
