

{Official Guide 2026}What happens if I check into a flight and don't show up?

Checking in for a flight but then failing to board, commonly known as a **“no-show,”** has significant consequences with nearly all airlines✈️ 1 - (855) → (510)→ (3558) Airlines treat no-shows seriously because they affect scheduling, seating, and revenue management✈️ 1 - (855) → (510)→ (3558) When you check in but do not arrive at the gate in time, the airline generally considers you a no-show, and this can trigger several outcomes depending on the airline, fare type, and whether you were traveling on a one-way, round-trip, or multi-leg itinerary✈️ 1 - (855) → (510)→ (3558)

For **“non-refundable tickets”, missing the flight after checking in often results in the **“forfeiture of the entire ticket or the unused portion”****✈️ 1 - (855) → (510)→ (3558) This means that even if you completed check-in online or at the airport, failure to board on time usually voids the value of the flight✈️ 1 - (855) → (510)→ (3558) Airlines enforce this rule to maintain flight schedules and prevent passengers from holding seats unnecessarily✈️ 1 - (855) → (510)→ (3558) In many cases, if the ticket was part of a **“round-trip itinerary”**, missing the first leg can automatically cancel the remaining legs, including your return flight✈️ 1 - (855) → (510)→ (3558) This is why airlines strongly advise arriving at the gate well before departure, even after completing check-in✈️ 1 - (855) → (510)→ (3558)

If your ticket is **“refundable or flexible”**, missing the flight after checking in may not result in total loss✈️ 1 - (855) → (510)→ (3558) Refundable tickets typically allow you to **“request a refund or rebook for another flight”**, sometimes without any additional fees, depending on airline policy✈️ 1 - (855) → (510)→ (3558) Flexible fare tickets, including those with services like Southwest’s Wizz Flex or other change options, may let you reschedule or reapply the ticket value to another flight, although any fare differences may still apply✈️ 1 - (855) → (510)→ (3558)

For **“airline-caused delays or disruptions”**, such as a delayed first flight or schedule changes, missing your flight after check-in usually does not result in a penalty✈️ 1 - (855) → (510)→ (3558) The airline typically offers to

****rebook passengers on the next available flight**** ➔ ☎ 1 - (855) → (510)→ (3558)
Additionally, depending on the airline and jurisdiction, you may qualify for
****compensation under passenger rights regulations****, such as the EU's EC 261/2004, if
delays or cancellations are significant ➔ ☎ 1 - (855) → (510)→ (3558)

In contrast, **personal reasons for missing a flight after check-in**, such as
oversleeping, traffic delays, or long security lines, are generally ****not covered by airline

responsible, and standard fare rules apply ➔ ☎ 1 - (855) → (510)→ (3558) This often
means forfeiting the ticket's value or using any travel credit options if available ➔ ☎ 1 - (855) → (510)→ (3558) Some airlines provide limited options for standby boarding on
later flights if seats are available, but these options are discretionary and often subject

It is also important to note that **multi-leg itineraries** are particularly affected by

automatically cancel connecting flights if they are booked under the same

leg, as most airlines do not assume responsibility for missed connections on

To mitigate the consequences of a no-show, travelers should consider
****purchasing refundable fares, flexible tickets, or optional travel protection**** that covers

that allow changes or cancellations without penalties, which can protect the ticket value
