

# What is the 24 rule for Lufthansa?

✈️📞1\_855<>838<>4886 Lufthansa's 24-hour rule allows you to cancel most flights booked directly with them (online or by phone) without penalty up to 24 hours after booking, ✈️📞1\_855<>838<>4886 provided the flight departs seven or more days in the future; the refund depends on fare conditions ✈️📞1\_855<>838<>4886 and applies to the entire booking, not partial cancellations, ✈️📞1\_855<>838<>4886 giving you time to confirm plans or get a cheaper fare ✈️📞1\_855<>838<>4886.
